





**Fingerprints Required:** All applicants are required to be fingerprinted. Please attach a receipt from a service provider or other evidence of compliance with this requirement.

**Bond Required:** An application for a license as a solicitor who demands, accepts or receives payment or deposit of money in advance of final delivery shall also be accompanied by a cash deposit of \$5,000 or a five-thousand-dollar surety company bond or other bond secured by sufficient collateral, said bond to be approved by the Village Attorney as to form and surety conditioned for making a final delivery of the goods, wares or merchandise ordered or services to be performed in accordance with the terms of such order or failing therein that the advance payment on such order be refunded. Any person aggrieved by the action of any licensed solicitor shall have the right by action on the bond for the recovery of money or damages, or both. Such bond shall remain in full force and effect, and in case of a cash deposit, such deposit shall be retained by the village for a period of 90 days after the expiration of any such license, unless sooner released by the Village Board of Trustees.
